

## **Glass City Metropark WiFi Access Agreement**

### **Access to the Service**

The Service is a free public WiFi service provided by Metroparks Toledo (Metroparks) and its hosts who provide Nodes and bandwidth ("hosts"). Your access to the Service is completely at the discretion of the Metroparks, and your access to the Service may be blocked, suspended, or terminated at any time for any reason including, but not limited to, time limits, violation of this agreement, actions that may lead to liability for Metroparks or its Hosts, disruption of access to other users or networks, and violation of applicable laws or regulations. Metroparks may revise this agreement at any time. By logging on to the service, you accept this agreement, and it is your responsibility to review it for any changes each time.

### **Acceptable Use of the Service**

Metroparks supports the free flow of information and ideas over the Internet. Although Metroparks has and accepts no obligation to monitor your use of the Service nor edit or censor content transmitted (via email, downloading, uploading, posting, or otherwise) through the Service, your access to the Service is conditioned on legal and appropriate use of the Service. Your use of the Service and any activities conducted online through the Service shall not violate any applicable law or regulation or the rights of Metroparks, its hosts, or any third party.

*The use of the Service for the following activities is prohibited:*

#### *Spamming and Invasion of Privacy*

#### *Defamatory or Abusive Language*

Using the Service to transmit, post, upload, or otherwise making available defamatory, harassing, abusive, or threatening material or language that encourages bodily harm, destruction of property or harasses another.

### *Forging of Headers*

Forging or misrepresenting message headers, whether in whole or in part, to mask the originator of the message.

### *Hacking*

Accessing illegally or without authorization computers, accounts, equipment or networks belonging to another party, or attempting to penetrate security measures of another system. This includes any activity that may be used as a precursor to an attempted system penetration, including, but not limited to, port scans, stealth scans, or other information gathering activity.

### *Distribution of Internet Viruses, Trojan Horses, or Other Destructive Activities*

Distributing information regarding the creation of and sending Internet viruses, worms, Trojan Horses, ping, flooding, mail bombing, or denial of service attacks. Also, activities that disrupt the use of or interfere with the ability of others to effectively use the node or any connected network, system, service, or equipment.

### *Facilitating a Violation of this Agreement of Use*

Advertising, transmitting, or otherwise making available any software product, product, or service that is designed to violate this agreement, which includes the facilitation of the means to spam, initiation of ping, flooding, mail bombing, denial of service attacks, and piracy of software.

### *Export Control Violations*

The transfer of technology, software, or other materials in violation of applicable export laws and regulations, including but not limited to the U.S. Export Administration Regulations and Executive Orders.

### *Other Illegal Activities*

Using the Service in violation of applicable law and regulation, including, but not limited to, advertising, transmitting, or otherwise making available ponzi schemes, pyramid schemes, fraudulently charging credit cards, pirating software, or making fraudulent offers to sell or buy products, items, or services.

### *Resale*

The sale, transfer, or rental of the Service to customers, clients or other third parties, either directly or as part of a service or product created for resale.
